

Important privacy statement regarding Cambridge Physics Experience (CPE) events

General introduction

The University of Cambridge and its Colleges are committed to widening participation to higher education. Each year hundreds of events are offered, including the Cambridge Physics Experience which you are attending, resulting in thousands of interactions with those considering an application to university. In order to ensure that these events are as effective as possible we conduct detailed evaluation and tracking analysis. This does not impact on an individual's current or future application in any way but enables us to continually adapt and improve our activities. We may cease to offer events and activities of which we are unable to demonstrate the effectiveness. Therefore, we greatly appreciate you taking the time to provide information and assure you that it will be handled in accordance with our privacy notice.

What we collect and why

Before a CPE event, we ask the person responsible for making the booking to indicate whether we need to make any special arrangements (e.g. for disabled access, religious observance etc.) Any information collected here will only be used for event organisation and will be destroyed afterwards. This is asked anonymously (i.e. without requiring the identity of the person for whom a special provision is requested) and is solely to ensure the safety and welfare of participants and the smooth running of our activities. *Choosing not to provide this information may mean we are unable to make any adjustments required for you to participate fully in the event. If you do not inform us about something for which you require adjustment, or which affects your safe participation in the event, this may result in you being unable to participate.*

We also ask for the **contact details of the person making the booking**. This is to enable us to send joining instructions for your event. We would also like to keep in touch after this event and send you details of future CPE activities which may be of interest: please tick the relevant box in the Eventbrite booking form if you are happy to be contacted for this purpose by e-mail (you can change this at any time by getting in touch using the email address above): if you wish to not be on our contact list at any future time after the event, we will remove your name from it.
